

## IRMSL Men's 3.5 Summer Tennis League

### April to June 2026

### Organizational Guidelines

1. Play by USTA Rules and Friend at Court unless IRMSL Tennis League rules are in place to specify otherwise.
2. Appropriate tennis attire required at ALL clubs - **NO cut-off shirts or tank tops.**
3. Four (4) teams in the league – 2026
  - North River Shores Riverland I/Schwartz Riverland II/Harvo Summerfield
4. Play **Tuesday** mornings with team management/schedules/scoring via [IRMSLtennis.topdoglive.com](https://irmsltennis.topdoglive.com)
  - Match start times will be between 8:30am & 11:00am
  - NO guest fees will be charged to the visiting team
  - Scores should be entered by 8pm on match day
  - Either captain can enter the scores
5. Each team needs a minimum roster of eight (8) players
  - Minimum age is 45 years old
  - Skill/ability level 3.5
    - NO 4.0's and above
  - **DEADLINE** to add players to the rosters is **Monday 6/15/26**

  - Players must be added to the team roster before they can play in a match
6. Rostered players SHOULD BE a member of the participating club.
  - If a non-member is requested, contact Jessica. She will research the player and upon approval will add him to your roster.
7. Three (3) courts/positions of doubles will be played per match.
  - One (1) point per court/position awarded to winning team with three (3) points max per match.
  - An optional 4<sup>th</sup> court CAN be played IF both captains agree but NO POINTS will be awarded.
  - Captains to advise opponents at least 24 hours in advance of any defaults
8. Play best 2 out of 3 sets with a super tiebreak (1<sup>st</sup> to 10 by 2 points) in lieu of playing a full 3<sup>rd</sup> set.
  - If all 4 players agree to play a full 3<sup>rd</sup> PRIOR to beginning play, a full 3<sup>rd</sup> set may be played.
    - Recorded as 1-0
  - A regular tiebreak to determine winner of 1<sup>st</sup> or 2<sup>nd</sup> set (1<sup>st</sup> to 7 by 2 points).
  - ALL tiebreaks will follow the [Coman Procedure](#).
9. Play strongest pair (court/position #1) to weakest pair (court/position#3) – Captains discretion.
10. 2026 league season will run – based on four (4) teams –
  - 4/21 to 6/23 – play other teams three (3) times each
  - No play week of Memorial Day (5/26)
  - No play offs
11. Rain Outs - match will be added to the end of published schedule of play (after 6/23/26)
  - Avoid haggling over makeup arrangements
  - CAPTAINS must notify me of rain outs or unplayable courts so schedule can be adjusted
12. 2026 IRMSL administrative fee remains at **\$125.00 per team** -
  - I will invoice each team once the playing season has started
  - Checks made to JABAAR, LLC \* PO Box 518 \* Palm City, FL 34991
